The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for SAN AUGUSTINE COUNTY from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that SAN AUGUSTINE COUNTY may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that SAN AUGUSTINE COUNTY is proposing to increase property taxes for the 2025 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 26, 2025 AT 09:00 AT COMMISSIONER COURT ROOM at 100 W Columbia, Room 103 San Augustine, TX 75972.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, SAN AUGUSTINE COUNTY is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the SAN AUGUSTINE COMMISSIONER'S COURT of SAN AUGUSTINE COUNTY at their offices or by attending the public hearing mentioned above.

The SAN AUGUSTINE COUNTY Auditor certifies that SAN AUGUSTINE COUNTY has spent \$64,400 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. SAN AUGUSTINE COUNTY Sheriff has provided SAN AUGUSTINE COUNTY information on these costs, minus the state revenues received for reimbursement of such costs. This increased the no-new-revenue maintenance and operations rate by \$0.00264/\$100.
