Permit holder is responsible for liability as to damages of whatever nature to the road bed, road surface, bridges, culverts, signs, structures, fences, trees, right to way, etc. that may result from said movement of loads over any portion of the San Augustine roads. **Transportation Code 251.160 Liability of Owner or Operator for Road Damage**
